Our technologies are developed and licensed under the name "**Bridge E-Commerce & Technocrats Private Limited**" from India.

Our accounts are monitored and audited by Chartered Accountants and Company Secretaries associated with our investment firm, "**Bridge Funding & Investments Limited**," operating in Hong Kong and India.

Our HFT Platforms are managed by "**Fixed Income Platforms LLC**," based in the USA & "**FIP Trade Factory**" from India.
